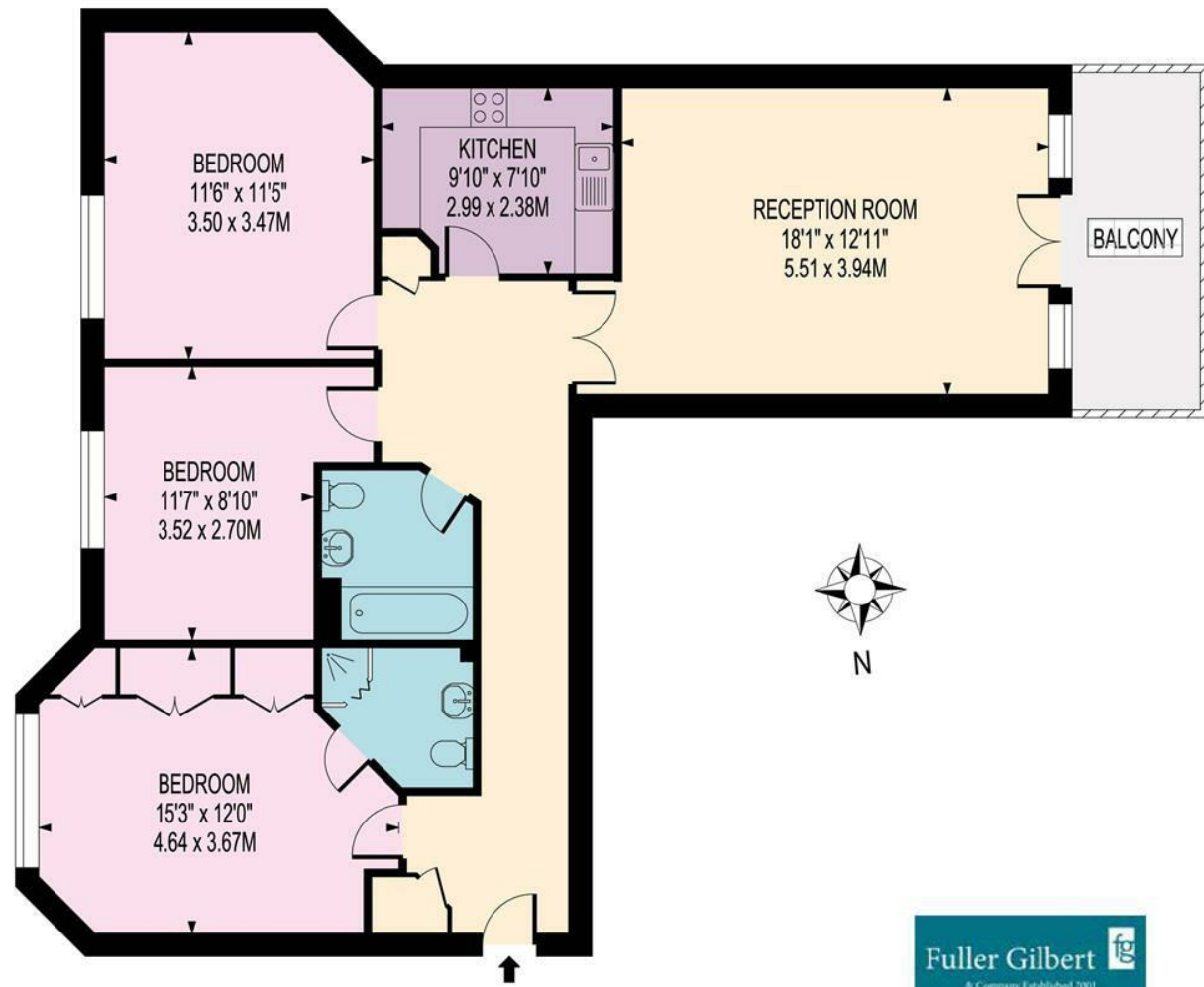


CHAPMAN SQUARE

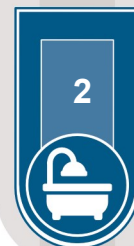
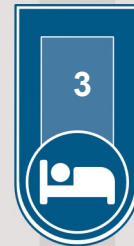
